2023 UPDATE OF WATER, WASTEWATER, & STORMWATER RATES

Wastewater

 SARA wholesale residential charges are increasing by approximately 14.1% in 2023 for each residential customer. Continued increases of about 10.9% for FY24 followed by an increase of 5% in FY25.

- SARA commercial rate increases will be 1.5% in 2023. Future years rate increases are generally 5% or less.
- SARA treatment expenses are expected to increase by about \$405,000 between FY 22 and FY 27 (or a 35% increase).

- Wastewater
 - CCMA wholesale treatment expenses are expected increase by 9% in FY 23 and increase about 3.5% per year thereafter. This increase is due in part to rate increases and growth in customers.
 - Money has been included for wastewater rehab projects (\$250,000 in 2023 increasing to \$300,000 in 2025).
 - Funds were included for Public Works Yard capital improvements in all years (\$78,000/year).

 Cost of other commodities (gas, electricity, materials) have increased drastically over the past year.

- Water
 - Ongoing projects are being funded through current bond money.
 Three additional tanks (Plant #8, #9 and #10) will be cash funded from cellular water tank revenue.
 - Additional money has been included for water rehab projects (\$250,000 in 2023 – increasing to \$300,000 in 2025).
 - Funds were included for Public Works Yard capital improvements in all years (\$22,000/year).
 - New debt (\$222,600/year) for Well #12 Replacement and Well Site 10
 & 11 Ground Tank Replacement, and land acquisition.





WATER/WASTEWATER FUND

The proposed rate increase for FY23 results in an increase of \$7.49/month for a residential customer with 10,000 gals. of W use & 6,000 gals. of WW use.



WATER/WASTEWATER FUND



- Stormwater
 - $_{\odot}$ There was a 5% rate increase last year.
 - Past increases, have helped provide the utility with more funds for ongoing capital projects; however, project cost continue to increase.
 - Goal is to fund \$250,000/year of capital projects. Projected capital spending for FY23 is \$290,500.
 - $_{\odot}$ Cost of other commodities have increased as well.

RATE CHANGES

- Recommended
 - $_{\odot}\,20\%$ increase for FY23, no future planned rate increases
- Alternative
 - $_{\odot}\,15\%$ increase for FY23
 - $_{\odot}\,5\%$ increase for FY24
 - $_{\odot}\,1\%$ increase for FY25


RATE CHANGES

 With recommended change, largest SF customers bill would increase \$0.93/month to \$5.63.
