Chris, I didn't see any specific definition for Apartment complexes or Residential Units that are more than 4 single family units. I'm assuming they fall under Commercial Waste, but we may want to spell this out a bit more.

Chris, I know there are some locations where ALLEY pick up will have to occur. This map needs to be clarified and agreed upon before the City Council meeting on the 20<sup>th</sup> so we can speak to it. Please provide the staff a copy of that map as soon as possible.

All, I did a "Councilman Neville" review for typos. The document margins are justified so every now and then there are two words smashed together. If you find any that I missed, please correct it. Also, since this document will be flying back and forth over the next 24 hours, please put **the time sent** in the "subject" box and track all changes that you make.
