Good morning Veronica,

Yes mam, certainly.

Each container will be a 96 Gallon Polycart. The 96 Gallon Polycart used for trash will be all green. The 96 Gallon Polycart used for recycle will have a green body and yellow lid.

WM's District Operations maintains an inventory of 96 Gallon Polycarts for our residential franchise customers. This is the standard size we recommend and provide in our Texas/Oklahoma market area.

At this time, I would suggest that we aim to keep residents with the two polycarts (1 Trash/1 Recycle) and avoid releasing additional carts until WM and the City execute a restated agreement. This will allow modified monthly rate to be assessed under the residential customer's account for the additional cart. If we offered additional carts at this time I believe it would create some confusion down the line if and when a restated agreement is executed.
