Good afternoon Kim,

WM currently has a service agreement in place with JISD to service facilities within franchised communities we serve. The same goes for Alamo Colleges District's campuses like Northeast Lakeview College. In speaking to my colleague, who manages our education accounts, I understand that a recycling compactor is currently located on the campus.

WM is open to providing education material and recycling containers to be used at JECA by [REDACTED] and her classmates. If everyone is in agreement, the students can simply load the recyclable material collected into the campus' compactor. If another container is needed onsite for WM to collect the students recyclables for processing, we can update the appropriate account (JISD or Northeast Lakeview) with the appropriate approvals.
